
Role and Responsibilities of Anti Ragging Squad:

- Posters explaining anti-ragging policy of NIET are displayed around the campus, clearly stating the activities which are considered as ragging and punishments prescribed by the law for such activities. In addition, the anti-ragging policies and related details are also made available in the College Website, Student Hand Book and College Policy Book
- Affidavits, as per the direction from the Government and Anti-ragging undertaking are collected from all the students and their parents
- At the commencement of the academic year, through formal circular, students are instructed not to indulge in ragging and are explained about the anti-ragging policies and procedures
- Since the institution has implemented very strict policies and procedures to prevent ragging, so far, no complaints about ragging has been received either in the campus or in hostels
- CCTV cameras are also installed at various locations in the college as per the Government regulations as a deterrent for ragging and to monitor the activities
